MP3 Referrals are Accessible Online

Referrals for those members who would like to print copies of referrals issued by providers who participate in Motion Picture Preferred Providers ("MP3") may do so on the Motion Picture Industry Pension & Health Plans' website (www.mpiphp.org).

To print these referrals, your members should log on to the website using their personal credentials.

They may then access their referrals by clicking on the "Health" option at the top of the screen. Then, they should select "Referrals" from the dropdown menu under "Health" – to download a referral, select the corresponding "Referral Letter" on the screen. Only referrals issued after January 1, 2022 will be available.

As a reminder, your members will receive paper copies of referrals issued by MP3 providers in the mail.

Sutter Health Providers and Facilities are In-Network

Beginning March 1, 2022, Sutter Health providers and facilities, which are primarily found in the northern California region, will once again be in-network for participants of the Motion Picture Industry Health Plan.

Using New Identification Cards

Members who are enrolled in Anthem Blue Cross ("Anthem") will receive new Anthem identification cards that they should use beginning March 1, 2022.

The Anthem cards will be available on the Anthem.com website after March 1, 2022.

New Health Plan Benefits for Your Members

PLEASE NOTE THE FOLLOWING NEW BENEFITS:

- ▶ Effective October 1, 2021, with the exception of opioids, a 90-day supply of Schedule II medications may be obtained through the mail.
- ▶ Effective December 1, 2021, disposable, patch insulin systems are covered under the pharmacy benefit.
- ▶ Effective December 1, 2021, dental sealants for members or their dependents, up to age 18, are covered.
- ▶ Effective January 1, 2022, conscious sedation is covered under Delta Dental PPO or DeltaCare USA for dental procedures performed in the office setting. The conscious sedation is to be administered by the dentist performing the dental procedure.
- ▶ Effective January 1, 2022, for members enrolled in Anthem Blue Cross and Oxford Health Plans ("Oxford"), Applied Behavioral Analysis (ABA) to treat autism spectrum disorder (ASD) is covered. For Anthem Blue Cross members, it is covered through Optum Behavioral Health and for Oxford, it is covered through the Oxford benefit.
- ▶ Effective January 1, 2022, the VSP frame allowance increased to \$200 every other calendar year.
- ▶ Effective January 1, 2022, for members enrolled in Anthem Blue Cross, urine drug screens, up to four per year and at up to \$100 per test, will be covered.
